Greetings Vista Grande Villa Residents and Loved Ones,

Assisted Living Update:

As you may have seen on the updated graph above, we have had four assisted living residents test positive for COVID-19 as well as one staff member. We have taken quick actions to quarantine any positive individuals as well as possible exposed residents. At this time, until we feel we can confidently say we have this outbreak fully identified, we are asking all residents to remain in their suites as much as possible, and we have started in-home dining again. All positive and exposed residents are residing on the same wing and must remain in their suites. Staff are caring for them at a lower staff to resident ratio in order to more closely monitor and provide supportive care. Staff exchange will be minimal, in order to decrease the risk of transmission to other residents or staff members.

If you or your loved one has tested positive, you have already received this information. We will continue to diligently monitor all residents for any signs and symptoms of COVID-19 which has been effective in keeping this area COVID-negative for ten months. Please pray that this outbreak has been caught quickly with minimal spread.

Vaccine Update:

Independent Living: We have confirmed that our IL residents will not be included in the CVS vaccination dates. I am working with the Jackson County Health Department to see how quickly we can work through a vaccination solution. As always, as soon as I have any information, I will provide it to you.

Assisted Living/Memory Care/Skilled Nursing: We can FINALLY say we have our clinic dates! I apologize for the short notice as we were only given a few days to prepare. **CVS will be on site at Vista Grande Villa, this Thursday and Friday, January 7th and 8th** to provide the Moderna COVID-19 vaccine to interested residents. Staff in these areas will be reaching out to the resident or responsible party to obtain consent prior to Thursday. We appreciate your quick return of these forms as it is required by CVS.

Other Vaccine Information:

*We do not have a confirmed second vaccination clinic date set (COVID-19 vaccine requires two doses). Anticipate that this will take place 3-4 weeks after the first vaccination.

*Staff will be given the opportunity to receive the vaccination during this week's clinics as well. We hope that many will choose to receive the vaccine and further decrease the risk of COVID-19 at Vista Grande Villa.
